### **I. Monthly cost of a CSA Farm Share**

I am interested in buying a CSA Farm share from *Apponagansett Farm and the New Bedford Farm Share Program*. **Please check one of the following ways to pay for the CSA/Farm Share:**

\_\_\_\_\_ I agree to pay **\$10.00 per week** for a total of **\$40.00 per month** from June-October for a Regular Summer Farm Share (~ 6-7 items of produce per week) either by cash or check.

\_\_\_\_\_ I agree to pay **\$6.00 per week** for a total of **\$24.00 per month** from June-October for a Small Summer Farm Share (~ 4 items of produce per week) either for cash or check.

**II. I understand that:**

- I will receive farm produce weekly, which will be available for pick up at 134 South Second Street in New Bedford (near Boa Vista Parking Lot), every Wednesday from June 14<sup>th</sup> - October 25<sup>th</sup> from 5:00 p.m. - 7:00 p.m
- It is my responsibility to pick up my share on my scheduled pick-up date, during the scheduled pick-up time (See above).
- **If I cannot pick up my share during the scheduled pick up times, it is my responsibility to inform the Farm Share Program by calling the Farm Share Hotline 508-817-1875. I understand that I can arrange for someone else (family or friend) to pick it up for me.**
- If I do not pick up my share during my scheduled pick-up time, it will be donated to a local food pantry, shelter or other institution that will make use of the produce and **I will not get a refund.**
- The types of produce in my share will change weekly. There is no guarantee on the exact amount of produce. Shares will vary in weight, size and type of produce.
- I cannot return my CSA Farm Share for a refund or exchange it for other produce. I can exchange with other CSA Farm Share
- I can cancel my participation at any time. If I no longer want to participate, I will ask *Apponagansett Farm* staff or call the Farm Share hotline at 508-817-1875.
- I will complete and return the cancellation form to *Apponagansett Farm* at least 5 days before the next scheduled pick-up date.
- I agree to participate in a brief survey about this CSA Farm Share at the beginning and end of the CSA Farm Share season.
- My copy of this agreement will serve as receipt of payment.
